### 260. Update on the Growing Patient Participation campaign

The fourth [update](#) on the Growing Patient Participation campaign has now been published. It includes a link to case studies of Patient Participation Groups (PPGs) as well as to the communications toolkit that has been developed to help both new and established PPGs. ### 261. Wincanton PPG using the web to promote its activities

Information about local activities is increasingly available online, in addition to the traditional newspaper model. Wincanton PPG now has a regular feature in the [Wincanton Window](#). This can be used to publicise events and to raise awareness of the PPG itself.

### 262. English NHS Plan unveiled for 2010-2015

The Secretary of State for Health, Andy Burnham, has published details of how the government intends to implement their [vision](#) of a preventive, person-centred and productive NHS. It should offer fresh opportunities for PPGs who are active in promoting health and encouraging self-care. Equally, it should strengthen the role that PPGs can play in working with their practices and beyond to improve the patient experience.

### 263. New guidance on promoting health

The Royal Society for Public Health has issued new [guidance](#) aimed at promoting health and well-being and reducing inequalities. This includes some powerful messages, such as:

- the importance of working with communities when designing health promotion approaches
- recognising that “promoting health is not (mainly) about services”
- the need to commission in a way that makes the healthier choices, the easier choices.
